

ORDINANCE NO. 24-750

BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, as follows:

Section 1. The City Council of the City of Huntsville, Alabama, finds that an application has been presented to the City of Huntsville requesting the vacation of a utility and drainage easement; that the applicants have represented to the City of Huntsville that **Peter Walton and Cheryl Walton**, are the owners of the property across which said easement lies; that said easement, or the portion being vacated, is not presently used and is no longer needed for a public or municipal purpose.

Section 2. Pursuant to the findings in Section 1 hereinabove, the Mayor of the City of Huntsville, Alabama, is hereby authorized, requested and directed to execute a quitclaim deed vacating the easement hereinafter described, said deed being substantially in words and figures as follows, to-wit:

QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, **CITY OF HUNTSVILLE, ALABAMA, an Alabama municipal corporation**, hereinafter referred to as "Grantor", in consideration of the sum of TEN DOLLARS (\$10.00), in hand paid to it by **PETER WALTON AND CHERYL WALTON**, hereinafter referred to as "Grantee", and other good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged, does hereby REMISE, RELEASE, QUITCLAIM AND CONVEY unto the said Grantee, all of the Grantor's right, title, interest and claim in and to the following described real estate situated in the City of Huntsville, County of Madison, State of Alabama, to-wit:

All that part of Section 23, Township 5 South, Range 1 East, of the Huntsville Meridian, more particularly described as beginning at a point that is South 43 degrees 27 minutes 59 seconds West 10.01 from Northeast corner of Lot 1 and the Northwest corner of Lot 2, of Cloud Nine Three Subdivision, recorded in Document #20111003000522730, in the Office of the Judge of Probate, Madison County, Alabama.

Thence from the true point of beginning North 49 degrees 13 minutes 38 seconds West 5.01 feet to a point; Thence South 43 degrees 27 minutes 59 seconds West 952.94 feet to a point; Thence South 88 degrees 28 minutes 00 seconds East 13.44 feet to a point; Thence North 43 degrees 27 seconds 59 minutes East 944.43 feet to a point; Thence North 49 degrees 13 minutes 38 seconds West 5.01 feet to the point of beginning.

Subject to all rights of ways and easements recorded or unrecorded.

TO HAVE AND TO HOLD unto the said Grantee, its successors and assigns forever, all of Grantor's right, title, interest and claim in and to the above described real estate.

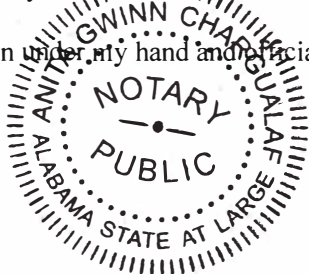

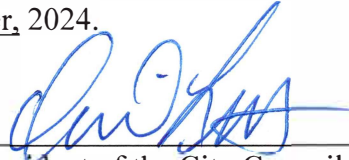
